The terms of the selling of hunts

Selling of hunts by direct acquisition is based on “General terms of selling hunts for foreign hunters” of the Regional Directorate of the State Forests in Białystok (RDSF) and detailed arrangements with forest inspectorates.

Hunt applications should be sent directly to the forest inspectorates, that manage the hunting districts (further called “hunt organizer” or “organizer”) to the following addresses:

The hunt applications should be sent at least 14 days before beginning of the hunt.

Advance

A hunter wishing to order a hunt is obliged to pay the advance on:

1. full board accommodation according to prior ordered hunting lodging category
2. organization of the hunt
3. trophy fees
4. other ordered services

The advance is paid at the sum of 100% of expected overall cost of the venture before the hunt, in the term and on the bank account indicated by the Forest Inspectorate.

The payment of the advance is the precondition of the hunt. Hunters will not be allowed to hunt unless the advance is paid and the ordering side bears responsibility for this to the clients.

Hunt settling is made on the base of the pricelist. All prices in this pricelist include VAT.

In the case of changing VAT rates, the prices may be changed.

The cost of money transfer is paid by the person making the payment.

The invoice for the provided services is issued by the organizer.

I. STAY SERVICES

1. Foreign guest's stay – per person

The price includes:

- guest's full board accommodation
- interpreter's work
- interpreter's full board accommodation

- a) accommodation in the hunting lodgings of category "S" or hotels * * * 325,00 PLN
 - an extra charge for single room or double room for one person use 40,00 PLN
 - in the case when more than two persons are in one room 280,00 PLN
- b) accommodation in the hunting lodgings of category I or hotels * * 280,00 PLN
 - an extra charge for single room or double room for one person use 40,00 PLN
- c) accommodation in other hunting lodgings regardless category and standard 230,00 PLN
 - an extra charge for single room or double room for one person use 30,00 PLN

If the presence of interpreter is not necessary while hunter's stay, charge for full board accommodation per person is lower respectively:

- a) accommodation in the hunting lodgings of category "S" or hotels * * * 260,00 PLN
 - an extra charge for single room or double room for one person use 40,00 PLN
 - in case when more than two persons are in one room 215,00 PLN
- b) accommodation in the hunting lodgings of category I or hotels * * 215,00 PLN
 - an extra charge for single room or double room for one person use 40,00 PLN
- c) accommodation in other hunting lodgings regardless category and standard 162,00 PLN
 - an extra charge for single room or double room for one person use 30,00 PLN

2. Staying services for accompanying children:
 - up to 4 years of age free
 - from 4 to 12 80% of main price
3. in case of exceeding the full day services (accommodation + full board) by one meal, additional payment will be taken per person 49,00 PLN
4. for the hunter's particular request a special meal (dinner or supper) may be served for an extra charge per person 70,00 PLN
5. The charge for dogs accompanying hunters (a day per one dog) 22,00 PLN

The price includes a dog's stay in hunter's room or any other place assigned. The food for a dog is provided by the hunter himself. The dog must be declared while ordering the hunt.
6. The charge for interpreter's services when a client is ordering only organization of the hunt without staying services (a day per person) 135,00 PLN
if a group consists of two or more hunters (a day per person) 70,00 PLN

In the case when organizer has to provide an interpreter with full board accommodation an extra charge is taken (a day per group) 200,00 PLN

II. ORGANIZATION OF A HUNT

The daily charge taken from each hunter a day

a) individual hunt	-	235,00 PLN
b) individual hunt for European bison	-	560,00 PLN

The charge includes the preparation of the hunting ground.

c) group hunt	-	520,00 PLN

The price for the organization of a hunt with beaters includes:

- provision of the necessary number of beaters
- transport during the hunt
- display of the trophies of the hunt
- giving occasional medals and certificates

Additional charge of $\frac{1}{2}$ of the individual hunt is taken when driven hunt is combined with evening individual hunt.

III. TROPHY FEES ¹

EUROPEAN BISON

Dates of hunt: November - February

Optimum length of stay - 6 days

1. wounding (bull or cow) - 12 200,00 PLN

2. Trophy – a skull with horns

Trophy fee according to CIC assesement done while filling the hunting protocol

a) **EUROPEAN BISON – BULL**

- gold-medal trophy (170,00 and more CIC points): 36 000 PLN

+ 600 PLN for each point CIC over 170 CIC points

- silver-medal trophy (150,00 – 169,99 CIC points) 26 000 PLN

+ 500 PLN for each point CIC over 150 CIC

- bronze-medal trophy (130,00 – 149,99 CIC points) 16 000 PLN

+ 500 PLN for each point CIC over 130 CIC

- without medal (up to 129,99 CIC points) 12 800,00 PLN

b) **EUROPEAN BISON - COW** 12 200,00 PLN

European bison is strictly protected game species. A hunt is available only on the Chief Nature Conservator's permission and must be carried in accordance with its terms.

Hunters pay at least for 5 day of organization of the hunt regardless of the actual stay.

¹ The charge includes the field preparation and the assessment of trophies (certificates are issued for trophies of European bison, red deer antlers over 5kg, roe bucks antlers over 350 g and wild boar tusks over 20 cm)

RED DEER

- stag 21st August - 28th February
- hind: 1st October – 15th January
- calf 1st October – 28th February

Optimum length of stay - 7 days

1. Wounding

- hind or calf: 280,00 PLN

hind or calf - 195,00 PLN

Discount: 20% on stags of antlers up to 3,49 kg in the period 1st January - 28th February

Roe deer

Dates of hunt:

- buck 11th May – 30th September
- doe and fawn 1st October - 15 January

Optimum length of stay - 5 days

1. Wounding

- buck 625,00 PLN
- doe and fawn 170,00 PLN

2. trophy fee

Bucks trophy: antlers (according to the weight of antlers with skull, nasal and occipital bone and upper jaw after diminishing by 90g)

- up to 149 g - 185,00 PLN
- from 150 g to 199g - 390,00 PLN
- from 200 g to 299 g - 660 PLN + 2,25 PLN for each 1 g over 200 g
- from 300 g to 349 g - 885 PLN + 16,70 PLN for each 1 g over 300 g
- from 350 g to 399 g - 1 720 PLN + 29,40 PLN for each 1 g over 350 g
- from 400 g to 499 g - 3 190 PLN + 35,70 PLN for each 1 g over 400 g

Wild boar

Dates of hunts:

- individual hunts – the whole year (all wild boars except sows)
- driven hunts from 10th October to 15th January
- sows (females older than two years) from 15th September to 15th January

Optimal length of stay 7 days

1. Wounding: 270 PLN

2. trophy: tusks

Wild boar with the length of tusks up to 13,9 cm (piglets, yearlings, two-year old and older wild boars, sows)

according to the weight of carcass after disemboweling:

IX. ADDITIONAL SERVICES

- 1) Charge for interpreter's services for collecting hunters at an airport or from the border
per group 200,00 PLN
- 2) The use of camcorder commercially needs separate agreement with the hunt organizer
- 3) Delaying or shortening the hunt
In case of delaying or shortening the booked stay, the hunt organizer will count
 - up to 2 days of stay and organization of the hunt above actual stay days (per hunter)
 - up to 2 days of stay above actual stay days (per accompanying person)
- 4). In case of canceling the hunt less than 7 day before the beginning of the hunt following charge will be taken:
 - 2 days of organization of the individual or group hunt per one hunter
 - 2 days of stay per one accompanying person
